
demographics

The residential and commercial density of the trade area served by City Place Center can be seen in its demographics. Within a one-mile radius of the project, the population totals 11,678 in 4,655 households with an average household income of \$123,458. The daytime population within the one-mile radius jumps to 52,485, of which 48,157 are workers.


Within a three-mile radius of the project, the population totals 90,273 in 35,130 households with an average household income of \$96,233. The daytime population within the three-mile radius jumps to 184,603, of which 136,408 are workers.

sundance square

Sundance Square is a 36-block downtown destination known as a pedestrian-friendly district offering retail, restaurant, entertainment, live theater and other options. Downtown Fort Worth, Inc., estimates that approximately 10 million people visit the district annually.

Also downtown, the city's Convention Center adjacent to Sundance Square is on track for a \$95 million redevelopment, as announced in early 2023. And Texas AM is investing \$150 million in the first phase of its planned three-building campus downtown, per a 2023 report. Groundbreaking is expected this June.
