GENERAL DETAILS

- Sunnyvale is a city of approximately 8,000 residents, located east of Mesquite and about 5 miles east of Dallas. The Subject Property is located at 428 North Aston Drive at the intersection of Clay Road. It is easily accessible by Highway 80 and Interstate 30, and nearby 635 (LBJ Freeway). Land uses within a 2-mile radius are 45% industrial, 25% single family, 15% vacant and 5% each for multifamily, office and retail.
- Availability – The building has been occupied by the property owner (O&C Services) since it was constructed in 2016. The owner is downsizing and will move out at the time of the sale closing or will lease the building for a short period after closing.
- The building is nicely finished inside with approximately 30% air-conditioned office area. The warehouse area has a pitched roof prepared for an overhead crane, two grade-level roll-up entrance doors, a loading dock door, and two large ceiling fans.

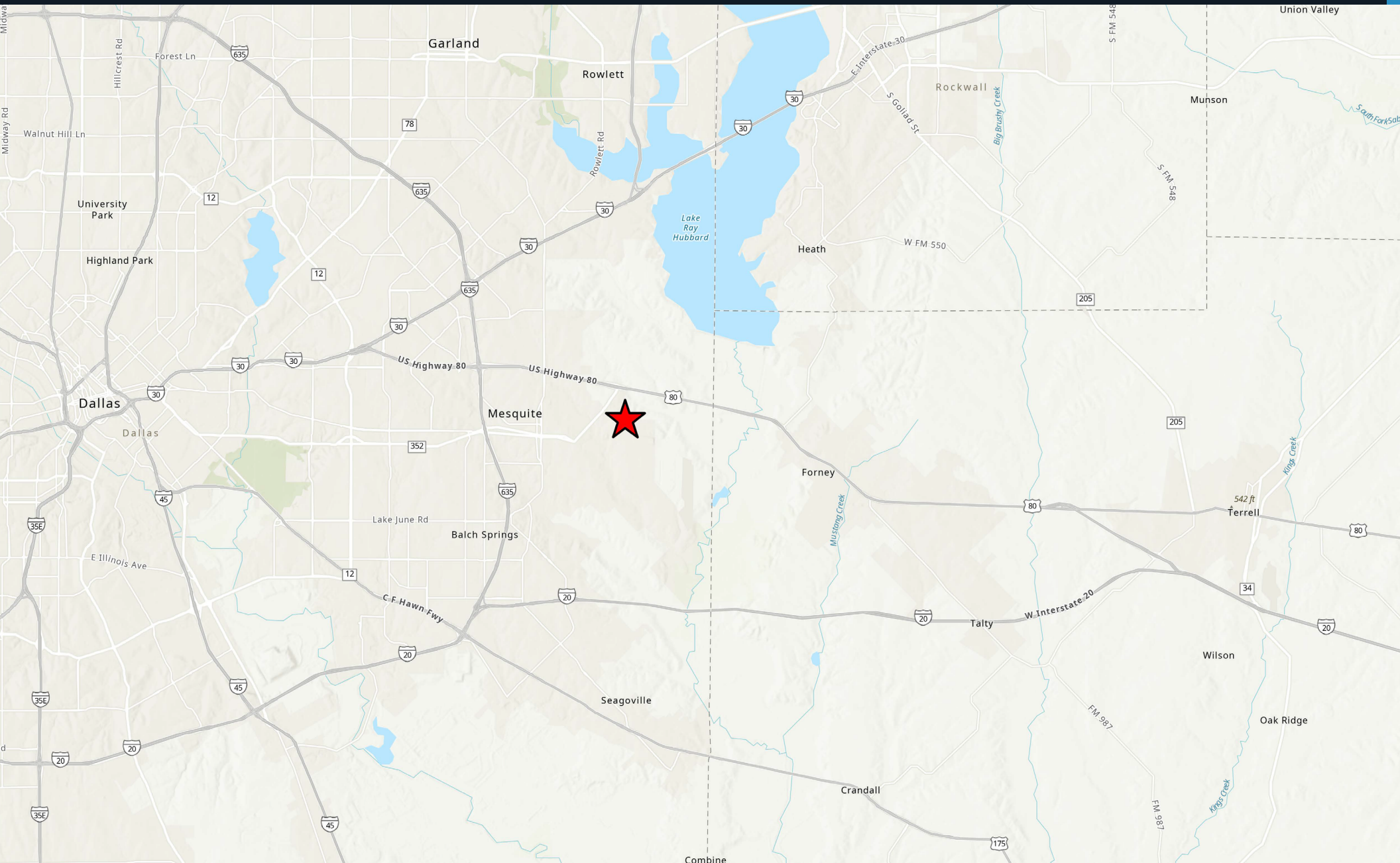

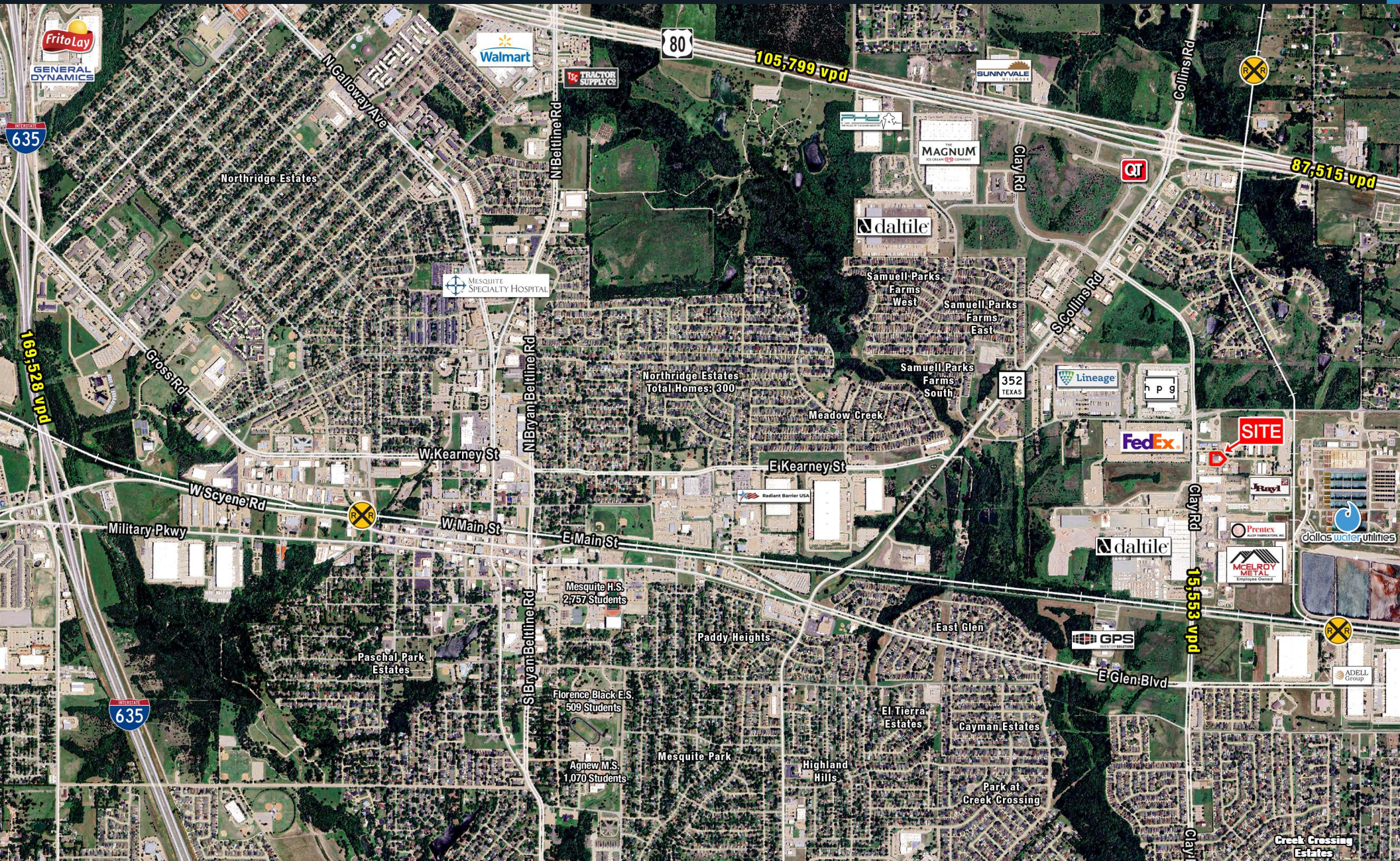

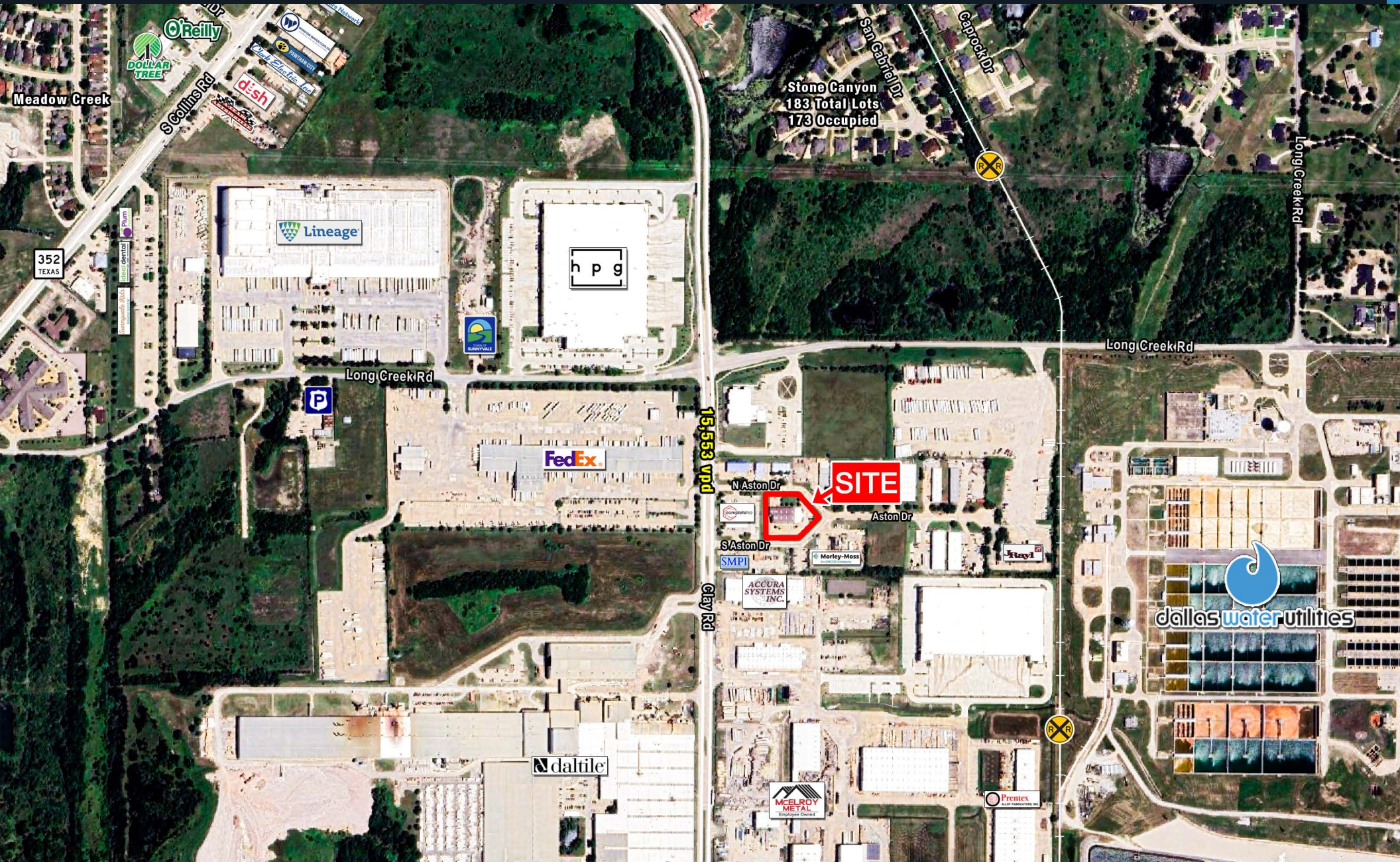
LOCATOR MAP



PROPERTY AERIAL



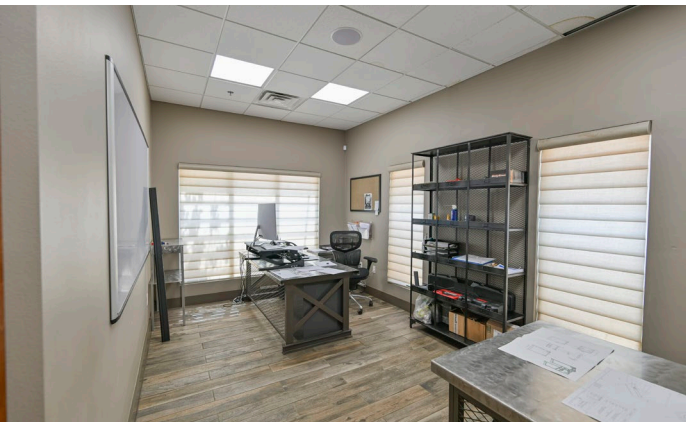
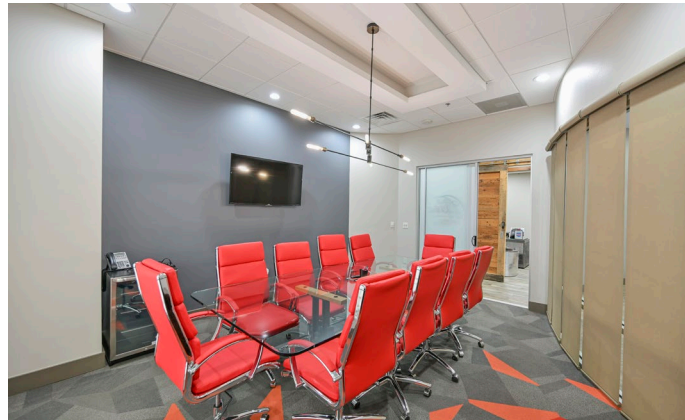
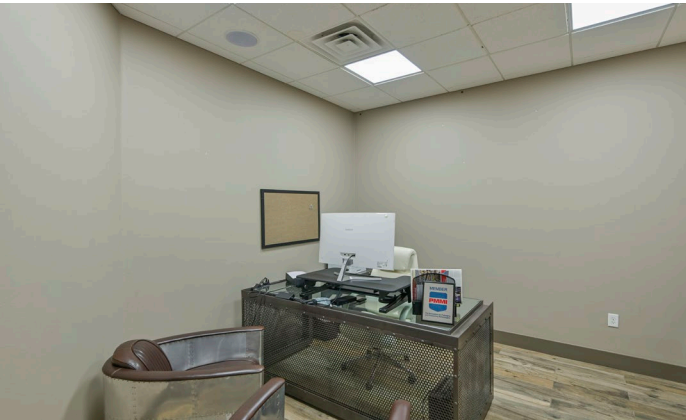
