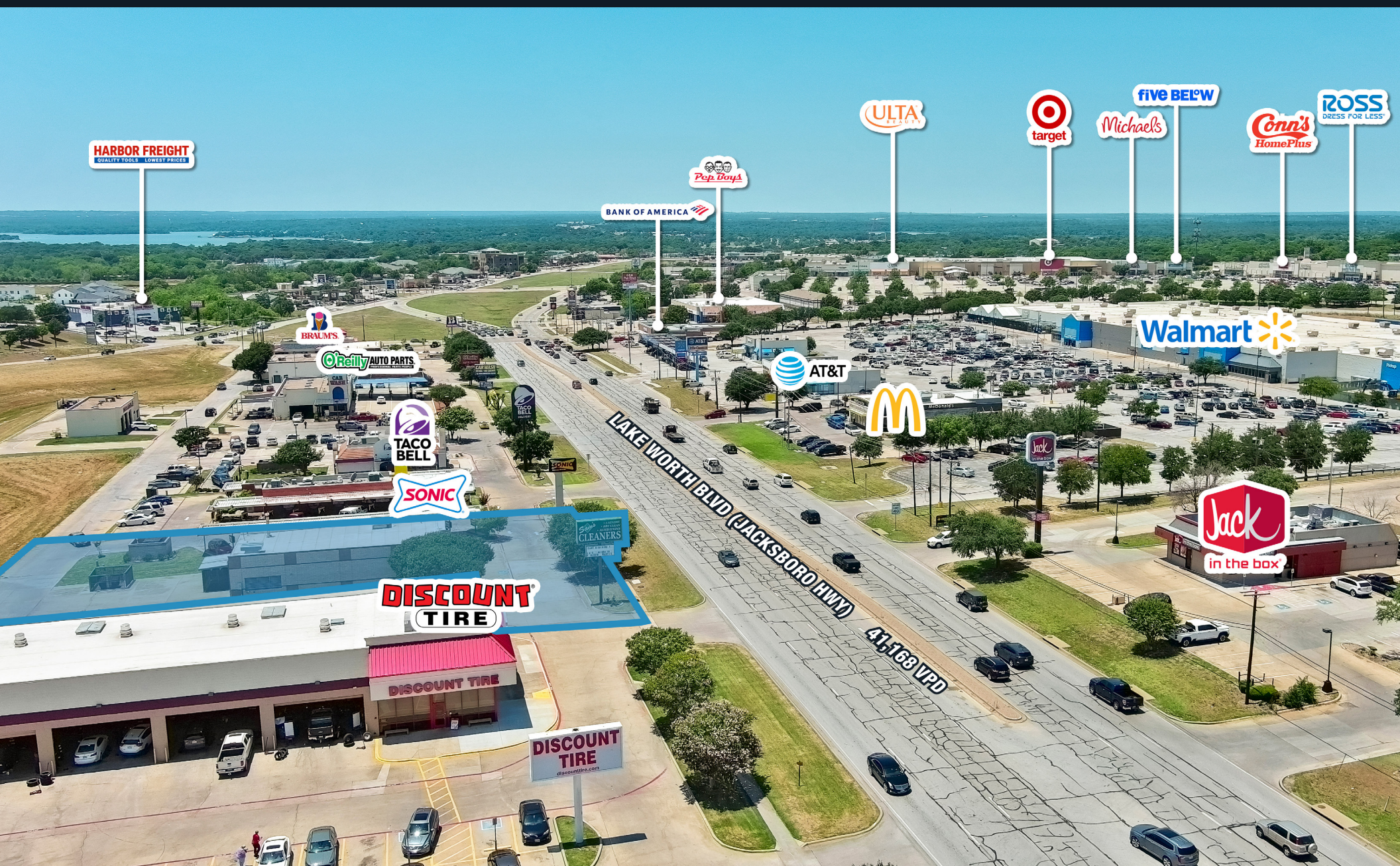

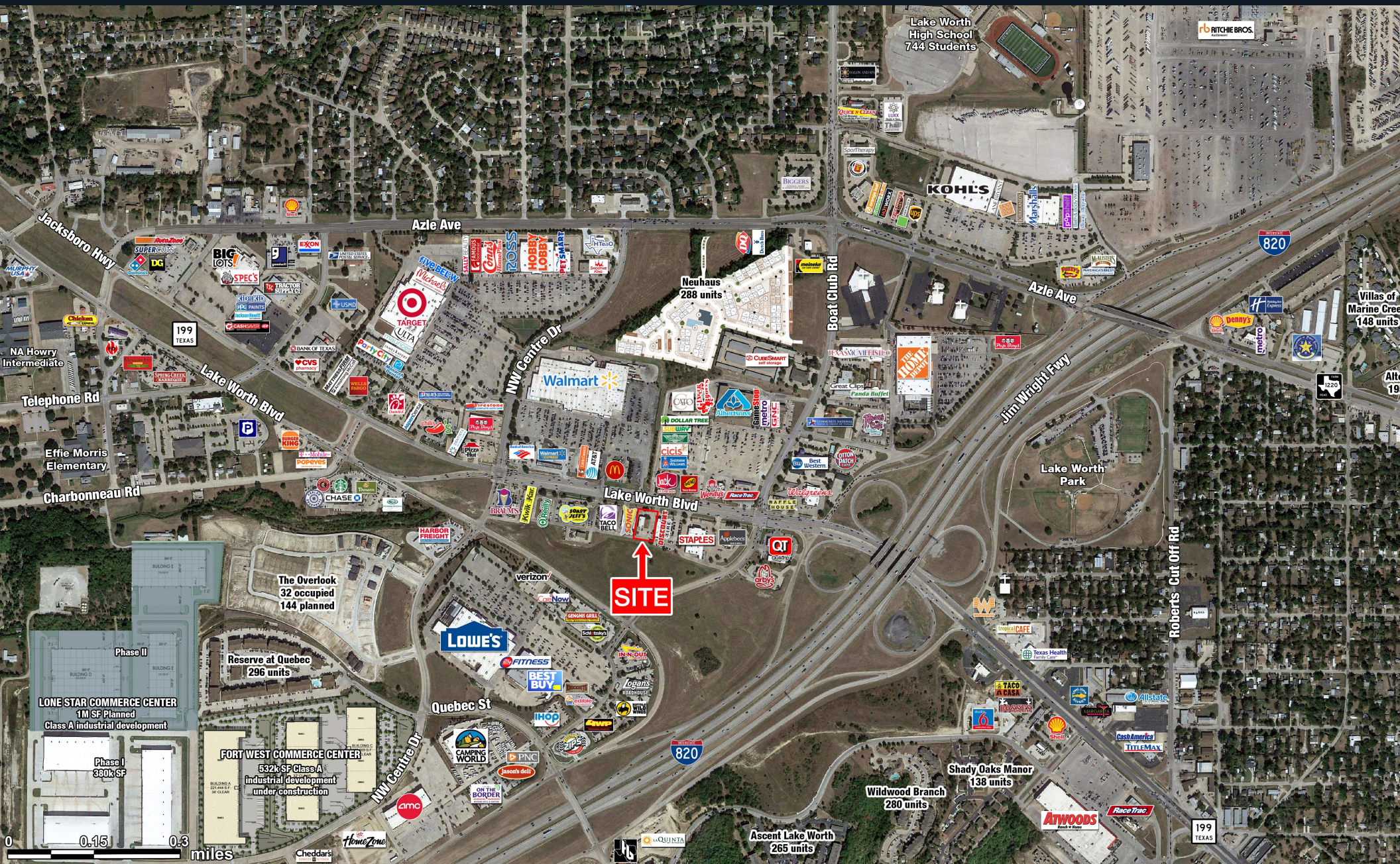

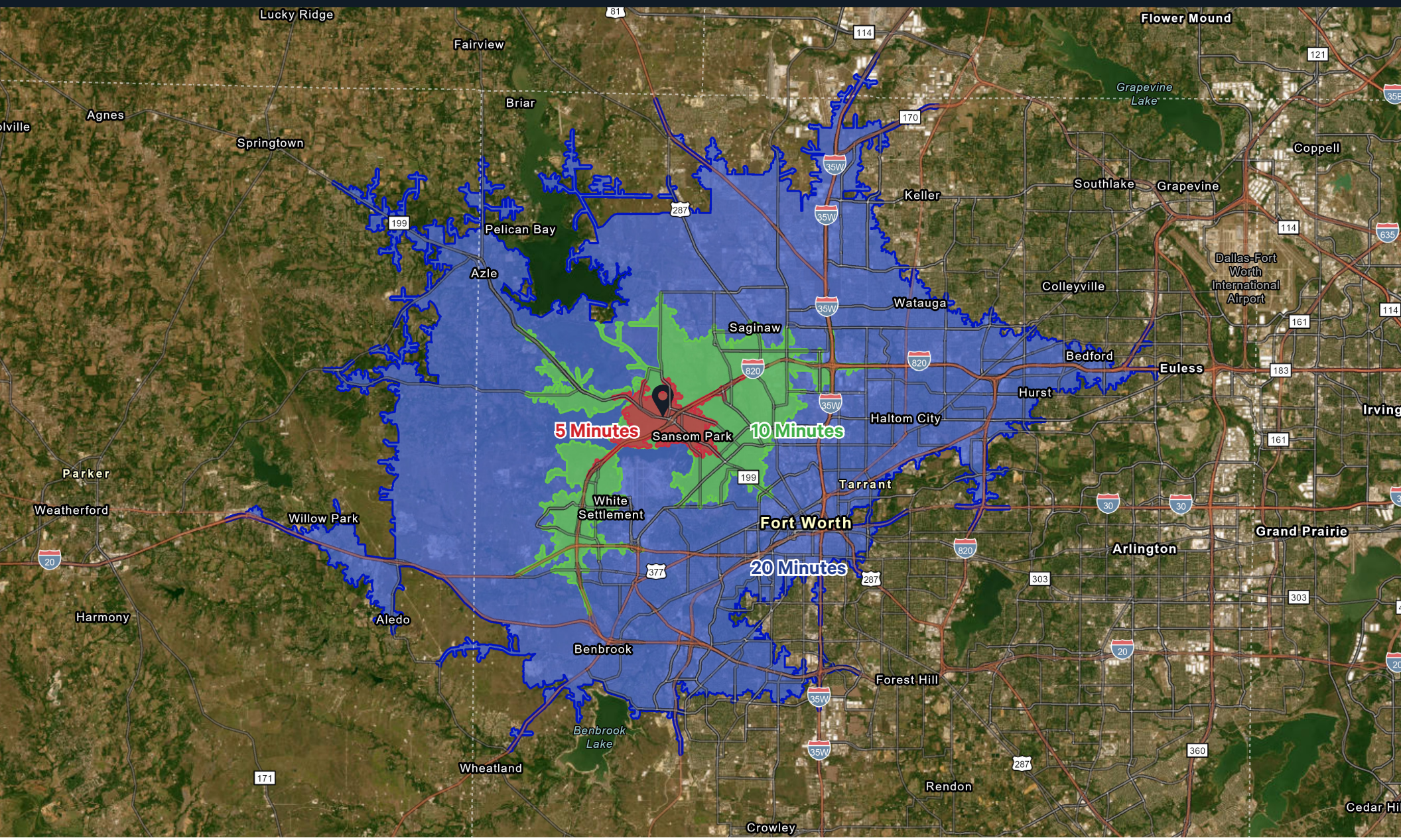

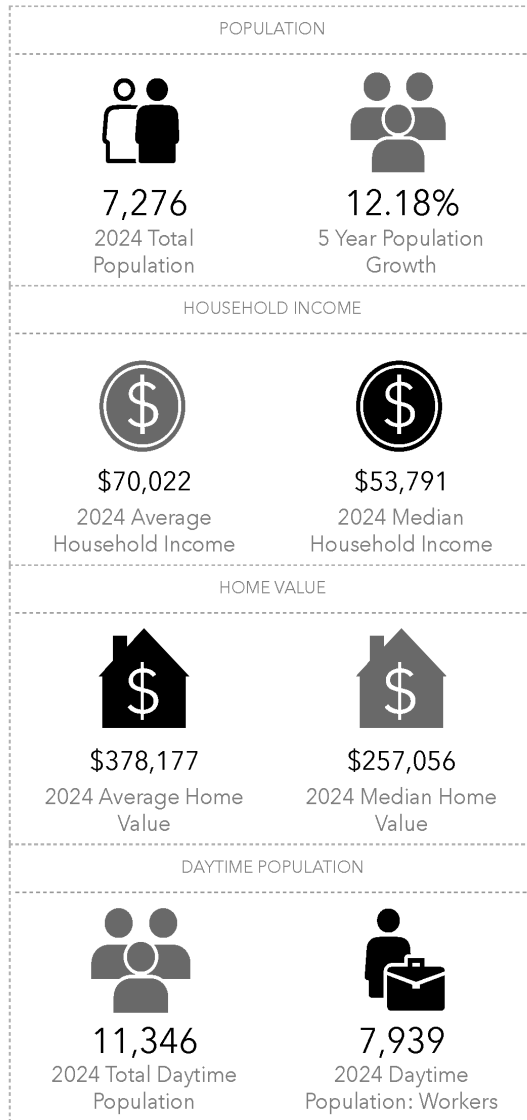

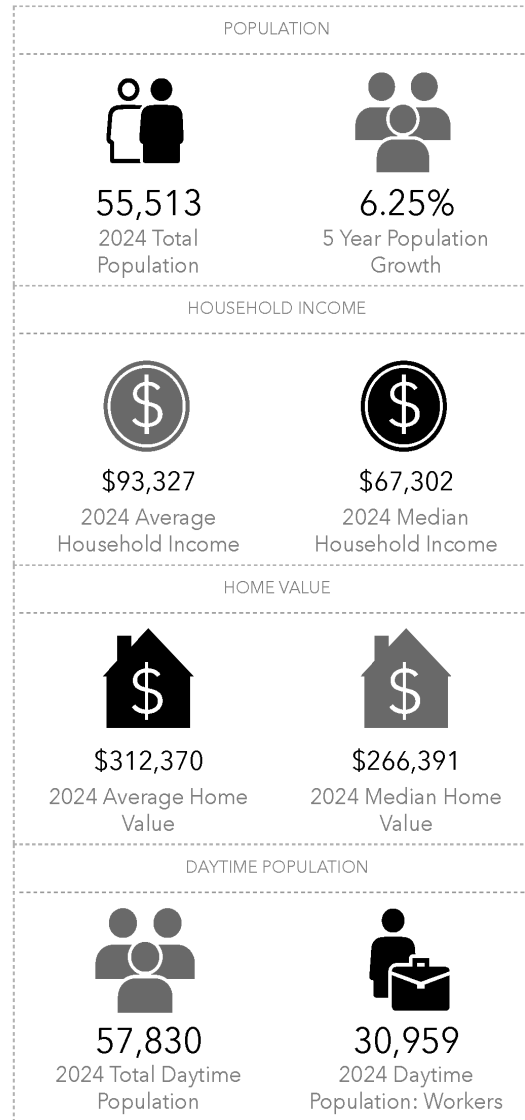

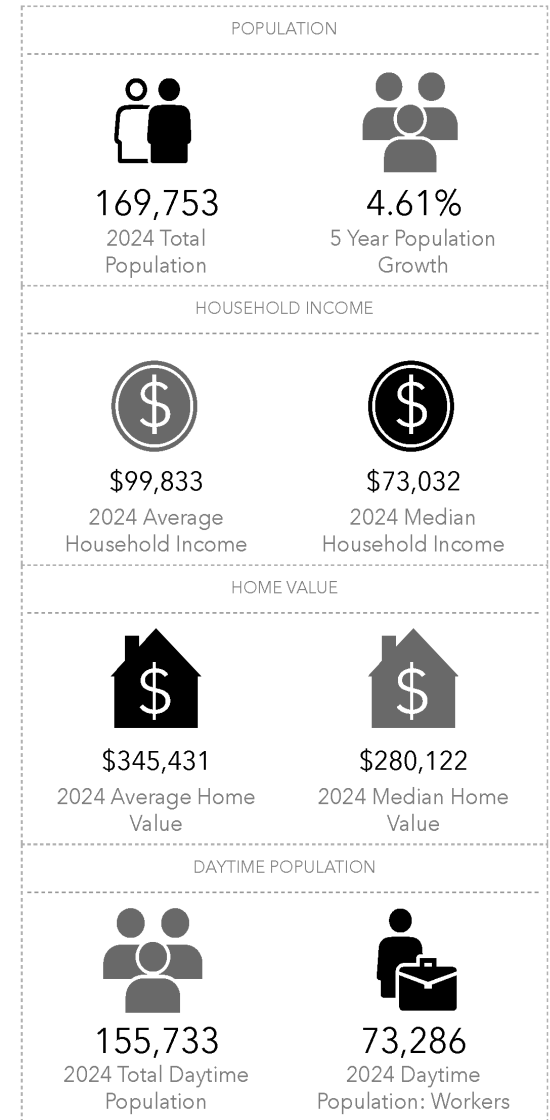

LAKE WORTH OVERVIEW
