










# AREA MAP





















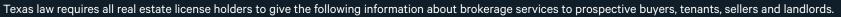

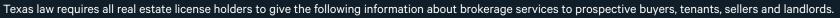
